## I. Call to Order and Roll Call

Chairman Friedman called the Central Coast Water Authority (CCWA) Board of Directors meeting to order at 9:00 AM.

### II. Closed Session

## A. CONFERENCE WITH LEGAL COUNSEL – EXISTING LITIGATION Government Code section 54956.9(d) (1)

Name of case: Central Coast Water Authority, et al. v. Santa Barbara County Flood Control and Water Conservation District, et al. (Case No. 21CV02432)

The Board went to closed session at 9:02 AM.

## III. Return to Open Session

The Board reconvened from closed session at 9:40 AM.

Ms. Stephanie Hastings, CCWA General Counsel, stated there were no reported actions as a result of the closed session.

### IV. Public Comment

There was no public comment related to items not on the agenda.

Upon a motion by Director Borah, seconded by Director Coates and carried with all in favor and none opposed the Board approved the Consent Calendar.

## VI. Executive Director's Report

## A. Water Supply Situation Report

Precipitation indexes for California were reviewed. Currently California is well above historical averages for precipitation throughout the state. State reservoirs are also at above historical average capacity, and snow pack is at record levels in some areas.

Additional detail related to San Luis Reservoir and the impact of it reaching capacity, including the availability of Article 21 water was provided. Mr. Stokes reviewed the calculation used by DWR to make Article 21 water available to State Water Contractors, noting that in the prior week CCWA participants took 94 AF of Article 21 water. He also reviewed the impact on Article 21 availability on participants' carryover water and the current status of carryover water.

It is anticipated that DWR will announce an increase in allocation on March 24, 2023, but there is no indication of the new allocation amount.

B. Legislative Update from the State Water Contractors Legislative Advocate, Glenn Farrell

A brief description of the State Water Contractor's (SWC) organization was provided by Mr. Stokes, who introduced Mr. Glenn Farrell, the SWC's legislative advocate. Mr. Farrell provided a synopsis of the legislative process, current State budget, and current legislation that may impact water resources and water providers in California.

C. Water Management Strategies: CCWA Powers and Contracting Vehicles

Due to the extreme vacillations in the water supply situation, as evidenced by the 2022-23 precipitation, a water management strategy is important to increase the reliability of imported State Water Project supplies for CCWA participants. A key component of water management is storage, and Mr. Stokes reviewed the actions already taken to advance the water management strategy, including investigating use of existing water banks, participation in proposed water banks, and reservoir storage projects outside the State Water Project.

Discussion took place regarding options for CCWA project participants to participate in these projects, either directly, or by CCWA on behalf of all or a portion of its project participants.

CCWA's scope of powers as outlined in its Joint Powers Agreement was explained by Ms. Hastings. She stated that if the Board is interested in pursuing new storage projects outside the State Water Project, amendment of CCWA's Joint Powers Agreement is recommended to expressly authorize CCWA to engage in these activities.

The Board requested information on the pros and cons of amending the Joint Powers Agreement for this purpose, and staff was requested to consult with member agencies' general counsels.

Staff were requested to bring the item back to the Board at a future meeting after consultation with member agencies' general counsels.

## D. Procurement of Three Trucks and One Sedan, Anticipated Expenditure: \$174,692.67

During the current and two prior fiscal years CCWA purchased vehicles through the California CMAS program, but the program is not effective in the current economic and supply chain environment. CCWA has taken its current vehicle needs for three trucks and one sedan to local auto dealers and requested bids. Mr. John Brady, CCWA Deputy Director of Operations and Engineering, provided detail on the vehicles being purchased and the bids received.

Upon a motion by Director Borah, seconded by Director Silva and carried with all in favor and none opposed, the Board authorized the Executive Director to procure the vehicles described by staff in the amount of \$174,692.67 and sell the replaced vehicles as surplus equipment at public auction.

## E. CCWA Preliminary FY 2023/24 Budget

An overview of CCWA's Preliminary FY 2023/24 Budget was provided by Ms. Dessilava Mladenova, CCWA Controller, highlighting differences between the current FY 2022/23 Budget and the proposed budget for FY 2023/24. She noted that changes to total payments by project participants were impacted by credits and the allocation of costs based on changes in deliveries and delivery estimates. Additional detail on credits, timing of participant assessments, components of the budget and delivery estimates was provided.

Operating expense changes were reviewed, and Ms. Mladenova provided detail on specific budget line items, including a decrease in utility expense resulting from an operational change to electrical usage, and detail on the capital and non-capital projects planned for the 2023/24 fiscal year.

It was noted that the Final Budget will be presented to the Board at its next regular meeting.

Mr. Cordero departed and Mr. Springer assumed representation for the City of Santa Maria.

## F. State Water Contractors Update

No additional information related to the State Water Contractors was provided.

No action was requested.

### G. Remote Meetings for Board of Directors and Committees

Ms. Hastings provided an explanation of the several mechanisms for public meetings under the provisions of the Brown Act, and the circumstances allowing Board members to participate remotely.

Following discussion, staff were directed to develop a resolution to allow the Board (and its committees) to participate remotely for special meetings only. The Board expressed its interest in continuing to meet in person at its regular meetings.

#### Note 3: DWR Reserve Fund

The DWR Reserve Fund was established to provide a funding source for payments to the State of California Department of Water Resources (DWR) when there is a difference between estimates used to prepare the DWR portion of the annual CCWA budget and the actual amounts billed to the Authority by DWR. Contributions to the DWR Reserve Fund are voluntary. Funding of each participating Project Participant's share of the DWR Reserve Fund will come from a combination of (1) CCWA Operating Expense budget surpluses, if any (2) Interest earnings on funds held in all other accounts on behalf of the participating Project Participant and (3) excess amounts, if any, from any of the DWR Statement of Charges cost components until the funding Target Amount is reached. The Target Amount will be equal to the participating Project Participant's proportional share of a \$10 million allocation of DWR Transportation Minimum OMP&R charges. **SUBJECT:** Budget Transfer for the Water Treatment Plant, Self-Contained Breathing

Apparatus Equipment Replacement Project, C-22SCBA

#### **BACKGROUND**

An important function of the Water Treatment Plant (WTP) is to disinfect water. The primary disinfectant in use at the WTP is chlorine gas. To handle this chemical safely, a number of engineered safety systems are in place to protect CCWA staff. Although there are engineered safety systems in place within the WTP, during certain procedures, such as changing out chlorine cylinders, it is necessary for staff to don self-contained breathing apparatuses due to the real risk of exposure.

Likewise, for the pipeline facilities, there are instances, such as disinfecting the interior of the pipeline with liquid sodium hypochlorite, where it may be necessary for staff to don self-contained breathing apparatuses.

Since the existing equipment is over 20 years old, they are at the end of their service life and need to be replaced for employee safety. This project is the second phase of a two-phase project to replace the existing equipment.

### **FINANCIAL**

CCWA staff moved forward with soliciting competitive bids for the required equipment, consistent with CCWA procurement policy. The results of the bidding are presented below:

The lowest responsive bid was \$38,240.63. The current available budget of this phase of the project is \$33,382. Therefore, we are overbudget by \$4,858.

CCWA staff proposes to transfer \$4,858 from the Tank 5 Chemical Dosing Facility Design Project, C-21T5ICDF. If you recall, as part of our carryover request to the Board, we transferred \$137,477 in excess funds to this project as a measure to address the likelihood of price increases due to inflation.

## Our proposed budget transfer is as follows:

SUBJECT: Bulk Chemical Contracts – Estimated Contract Value \$803,626.35

## **Background**

The operation of CCWA requires the use of various chemicals in bulk quantities for water treatment. CCWA purchases these chemicals using yearly contracts to secure reasonable and consistent pricing. The contracts allow for up to two one-year extensions, which are based on performance and proposed pricing for the extension period. In May 2023, the existing bulk chemical contracts will expire, including the two optional contract extensions. Consequently, CCWA solicited competitive bids for Liquid Aluminum Sulfate, Chlorine, Sodium Hydroxide, Ammonium Hydroxide, Sodium Hypochlorite, and Sodium Bisulfite.

#### **Discussion**

CCWA staff prepared a Request for Bid (RFB) for bulk water treatment chemicals. This RFB was emailed to the established CCWA chemical bidder list. It was also posted on the CCWA website and advertised through posting a notification in the legal section of the San Luis Obispo Tribune on March 24 and April 2, 2023. In response to the Bidders' written questions, one addendum was issued prior to the question period deadline.

Sealed bids were received and opened on April 12, 2023. Staff subsequently conducted a review of the apparent low bids to determine if the bid was responsive to the requirements outlined in the RFB. Upon review, it was determined that all of the low bidders were responsive to the contract requirements, except the chlorine bidders.

There were two chlorine bidders and each conditioned their bids. When bids are conditioned, they are not responsive to the bid documents because the additional conditions added to the different bids may or may not create an unfair competitive advantage to other bidders. The additional conditions that the two bidders presented are not identical and make a fair determination of the successful bidder difficult, if CCWA decided to accept the conditioned bids.

Both chlorine bids included additional provisions for Force Majeure. In addition, the JCI Jones bid included a 30-day notice price change provision and the Thatcher Chemical bid include a product warranty provision. These modifications to the bid documents were submitted to CCWA legal counsel for review. It was determined that the best and most fair course of action will be to reject both bids as non-responsive to the bid documents, then develop a new RFB to include the Force Majeure, price adjustment and product warranty provisions that would be mutually acceptable to CCWA and the bidders.

Chlorine continues to be in short supply and each of the provisions being requested by the two bidders should be fully considered and handled in a fair and equitable manner. Force Majeure has been declared numerous times over the last year and CCWA addressed this by agreeing to a quarterly price change negotiation.

#### **Financial Considerations**

Table 1 presents the results of the bid review, with the lowest responsive bid highlighted.

For comparison, Table 2 presents the previous contract prices and compares them to the responsive low bid pricing, chlorine was unresponsive. Using the water delivery volumes and quantity of chemicals utilized in 2022 for comparison calculation purposes, chemical costs would decrease by 1.5% with the 2023 bid pricing.

#### Recommendation

That the Board:

- Authorize the Executive Director to award the chemical contract to the following responsive low bidders:
  - o Chemtrade for Liquid Aluminum Sulfate at a cost of \$406.00 per dry ton
  - o Hill Brothers for Ammonium Hydroxide at a cost of \$2,475.00 per dry ton
  - o Univar Solutions Inc. for Sodium Hydroxide at a cost of \$924.00 per dry ton
  - o Univar Solutions for Sodium Hypochlorite at a cost of \$5.21 per gallon
  - Univar Solutions Sodium Bisulfite at a cost of \$1,704.00 per dry ton
- Authorize the Executive Director to reject the chlorine bid of JCI Jones and Thatcher Chemical as non-responsive to the Bid documents.
- Authorize the Executive Director to work with legal counsel to develop a revised Chlorine Request for Bids document that will include provisions for Force Majeure, price change during the contract period, and product warranty, as appropriate. Then solicit competitive bids for providing chlorine to the Polonio Pass Water Treatment Plant.

**SUBJECT:** Proposal to Eliminate the CCWA Finance Committee

#### RECOMMENDATION

That the CCWA Board of Directors approve Resolution No. 23-04 Eliminating the CCWA Finance Committee.

### **DISCUSSION**

At its meeting on March 26, 1992 (roughly six months after the formation of CCWA), the CCWA Board of Directors elected to create a Finance Committee as an advisory committee to the full CCWA Board of Directors. After its creation, the Finance Committee was active in advising the CCWA Board on many financial aspects of the construction finances, bond issuances, etc. However, after the completion of construction and full repayment of the CCWA bonds, the Finance Committee has only reviewed the quarterly investment reports and the annual review of the CCWA Investment Policy. All items reviewed by the Finance Committee are then considered by the full CCWA Board of Directors for approval.

Since the CCWA Finance Committee is simply reviewing the quarterly investment reports right before the CCWA Board meeting, the actions of the Committee are duplicated in the CCWA Board meeting. CCWA staff proposes to eliminate the Finance Committee and if it is determined the Finance Committee is needed again in the future, the CCWA Board can reestablish the Committee.

#### **ENVIRONMENTAL REVIEW**

CEQA Guidelines Section 15061(b)(3) provides a "common sense" exemption to environmental review that CEQA only applies to projects that have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to review.

The Board's approval of Resolution No. 23-04 does not have a potential for causing a significant effect on the environment.

- **Section 2**. Eliminate Committee. The Board herein finds it proper to eliminate the Finance Committee due to its diminished role. In the event staff or the Board finds reconstitution of the committee necessary, it may do so at a later time.
- **Section 3**. Effective Date. This Resolution shall take effect immediately upon its adoption.

#### **SUMMARY**

Attached is the third quarter FY 2022/23 investment report covering the three-month period of January to March 2023. In accordance with the CCWA Statement of Investment Policy, the quarterly report includes a statement of compliance of the portfolio with the investment policy and confirmation of the Authority's ability to meet expenditure requirements for the next six months.

#### **DISCUSSION**

As of March 31, 2023 the investment portfolio totaled \$32.6 million and had an effective rate of return of 2.81% on an average daily balance for the month of March 2023 of about \$33 million. The investments were comprised of the State of California Local Agency Investment Fund (LAIF), (\$31.4 million), and Montecito Bank & Trust money market accounts (\$1.2 million).

All investments during the quarter complied with the CCWA investment policy provisions.

## CASH MANAGEMENT PRO FORMA PROJECTIONS

Current pro forma projections indicate that the Authority will have sufficient cash with which to operate for the next six months.

We have reviewed the CCWA Personnel Policy Manual ("Manual"), consulted with Lisa Watkins, and suggest the following revisions.

1. <u>Equal Employment Opportunity</u>. Legislation effective January 1, 2023 expands protected characteristics to include "reproductive health decision making." Employees cannot be discriminated against or harassed based on their decisions to use or access a particular drug, device, product, or medical service for reproductive health. This requires revisions to Section 1.5 of the Manual as follows:

"CCWA supports equal employment opportunities and does not unlawfully discriminate against its employees or applicants because of race, race (including traits historically associated with race including, but not limited to, hair texture and protective hairstyles such as braids, locks, and twists), color, religion, sex (including pregnancy, childbirth, breastfeeding and/or related medical conditions), sexual orientation, national origin, ancestry, age (40 and above), marital status, military or veteran status, physical or mental disability, medical condition (genetic characteristics, cancer or a record or history of cancer), reproductive health decision making, gender, gender identity, or gender expression, genetic information, or any other characteristic protected by state, federal or local law. CCWA also makes reasonable accommodations, as required by law, for employees who have a physical or mental disability. Finally, CCWA prohibits the harassment of any individual on any of the basis listed above. This policy applies to all areas of employment including recruitment, hiring, training, promotion, compensation, benefits, transfer, and social and recreational programs."

3. <u>Sick Leave and CFRA Leave</u>. Legislation effective January 1, 2023 expands the reasons for which an employee may qualify for paid sick leave or leave under the California Family Rights Act ("CFRA"). Employees may take sick leave or CFRA leave to care for a "designated person." A designated person must be identified by the employee at the time they request leave, but is not required to be related by blood or even a familial equivalent relationship. Employees are limited to one designated person in a 12 month period. This requires revisions to the third paragraph of Section 3.4.1 and the first paragraph of Section 3.5.2.1 of the Manual as follows:

# Updated Section 3.4.1:

"Except as otherwise provided in this Manual, sick leave may be taken for a normally scheduled work period for the diagnosis, care or treatment of an existing health condition of, or preventative care for, an employee or an employee's qualifying family member or designated person (only one person may be designated in a 12-month period).

"Qualifying family member" is defined as the employee's spouse, child (including biological, foster or adopted child, stepchild, legal ward, or child of a person standing in loco parentis), regardless of age or dependency status; a biological, adoptive, or foster parent, stepparent, or legal guardian of an employee or the employee's spouse or registered domestic partner, or a person who stood in loco parentis when the employee was a minor child; domestic partner as defined in California Family Code section 297; child of a domestic partner; grandparent, grandchild, and sibling. Regularly scheduled work hours absent for medical and dental appointments will be treated as sick leave. Employees who are victims of domestic violence, sexual assault, or stalking may also use paid sick leave absences form regularly scheduled work to seek medical attention, obtain services from a shelter or crisis center, obtain counseling, or go to court. CCWA may request a written verification from a qualified health care provider for all absences due to the employee's illness, injury, or disability or the ability of the employee to return to work following the use of sick leave as provided in Section 3.4.2. CCWA may also request appropriate verification for the employee's use of sick leave in connection with a qualifying family member to confirm that the sick leave was used for a purpose consistent with this provision.

# Updated Section 3.5.2.1:

"Family care leave" may be requested under the FMLA and CFRA for (1) To care for or bond with your newborn child; (2) Placement of an adopted or foster care child with you; (3) To care for your child, grandchild, parent, parent in law, grandparent, sibling, spouse, registered domestic partner, or for CFRA only, a designated person (only one person may be designated per 12-month period) who has a serious health condition; or (4) To deal with a "Qualifying Exigency" arising out of the fact that your spouse, son, daughter, parent, or for CFRA only, your domestic partner is on active duty, or has been notified of an impending call to active duty status, in support of a "Contingency Operation." Qualifying Exigencies include, but are not limited to, such needs relating to the call to active duty as (a) issues arising from a short notice deployment with seven or less days of notice, (b) having to attend to childcare and school concerns, (c) attending military events, and (d) appointments to deal with financial or legal affairs, (e) counseling, (f) parental care activities, (g) rest and recuperation, (h) post-deployment activities. To additional qualifying exigencies, please contact the Human Resources Department. Additionally, FMLA and CFRA leave can be requested for a serious health condition that prevents you from performing one or more of the essential functions of your position."

4. <u>Bereavement Leave</u>. Legislation effective January 1, 2023 requires employers to provide five days of bereavement leave. Per our discussion with Lisa, we updated this policy to provide for five days of paid bereavement leave with the option to extend to seven days with Ray's approval. Section 3.11 of the Manual was revised as follows:

"Regular and probationary employees will be granted paid bereavement leave due to deaths in their immediate family for a period of up to threefive days, which may be extended with the Executive Director's approval up to a limit of sevenfive days where out-of-state travel to the services is involved. The term "immediate family" includes spouse, domestic partner as defined in Family Code Section 297, child, brother, sister, father, mother, step-parents, brother-in-law, sister-in-law, father-in-law, mother-in-law, and grandparent. If circumstances demand that additional time off be

taken, paid leave, to the extent available, or unpaid leave may be granted at the discretion of the Executive Director. Employee taking paid bereavement leave will be paid based on the number of hours the employee was scheduled to work on those days that are taken off under this section."

5. <u>Safety Program</u>. Based on the recommendation of your safety consultant indicating your Heat Illness Prevention program does not need to be separately called out in your Safety Program Policy, we suggest the following revisions to the second paragraph of Section 4.8.1 of the Manual as follows:

"The Company maintains an Injury and Illness Prevention Plan and other written safety programs specific to the applicable requirements of the General Industry Safety Orders well as a Heat Illness Prevention Plan, copies of which may be obtained from the Safety Officer. Employees should contact the Safety Officer or the Operations Manager with any questions about safety-related concerns."

6. <u>ACWA/JPIA Driver Record Review Program</u>. Based on your actual practice, we removed the section of this policy indicating that driving reports are delivered to the ACWA/JPIA on an annual basis. The updated Section 4.11 of the Manual as follows:

"The ACWA/JPIA Driving Record Review Program requires that all member districts: "Obtain from the Department of Motor Vehicles a copy of the driving record of all employees that are authorized to operate district-owned (or privately owned) vehicles on District business".

These reports are sent on an annual basis (every 12 months) to the ACWA\JPIA and a copy placed in a confidential file kept by the Executive Director or his designee."

7. <u>Harassment and Discrimination</u>. Similar to the changes made to your Equal Employment Opportunity Policy, legislation effective January 1, 2023 expands protected characteristics to include "reproductive health decision making." Employees cannot be discriminated against or harassed based on their decisions to use or access a particular drug, device, product, or medical service for reproductive health. Additionally, the California Department of Fair Employment and Housing is now referred to as the Civil Rights Department, and the California Fair Employment and Housing Council is now referred to as Civil Rights Council. Finally, the statute of limitations to file a claim has been expanded from one year to three years. These changes require updates to the first and final paragraphs of Section 4.16 of the Manual as follows:

"CCWA is committed to providing a workplace free of sexual harassment or discrimination (which includes harassment or discrimination based on pregnancy, childbirth, breastfeeding and/or related medical conditions) as well as harassment or discrimination based ancestry, age (40 and above), color, reproductive health decision making, gender, gender identity, or gender expression, genetic information, marital status, medical condition (genetic characteristics, cancer or a record or history of cancer), military or veteran status, national origin, physical or mental disability, race, race (including traits historically associated with race including, but not limited to, hair texture and protective hairstyles such as braids, locks, and twists), religion, sexual orientation, or any other characteristic protected by state, federal or local law. CCWA strongly

disapproves and will not tolerate unlawful harassment or discrimination against employees by managers, supervisors, or coworkers, as well as by non-employees in the workplace. Harassment includes verbal, physical, and visual conduct that creates an intimidating, offensive, or hostile working environment or interferes with work performance. Such conduct constitutes harassment when (1) submission to the conduct is made either an explicit or implicit condition of employment; (2) submission to or rejection of the conduct is used as the basis for an employment decision; or (3) the harassment interferes with an employee's work performance or creates an intimidating, hostile or offensive work environment."

"Sexual harassment, and retaliation for opposing sexual harassment or participating in investigations of sexual harassment, is illegal. In addition to notifying CCWA about harassment or retaliation complains, affected employees may also direct their complaints to the California <a href="Civil Rights">Civil Rights</a> Department of Fair Employment and Housing (DFEHCRD), which as the authority to conduct investigations of the facts. The deadline for filing complaints with the DFEHCRD is one-three (3+) years from the date of the alleged unlawful conduct with that deadline being extended by ninety (90) days in limited circumstances. If the DFEHCRD believes that a complaint is valid and settlement efforts fail, the DFEHCRD may seek an administrative hearing before the California Fair Employment and Housing Civil Rights Council (FEHCCCRC) or file a lawsuit in court. Both the FEHCCRC and the courts have the authority to award monetary and non-monetary relief in meritorious cases. You can contact the nearest DFEHCRD office or the FEHCCRC at the locations listed in the CCWA's DFEHCRD poster or by checking the state government listings in the local telephone directory.

The California Labor Commissioner, rather than the DFEH, processes administrative claims of sexual orientation discrimination. The deadline for filing complaints with the Labor Commissioner is thirty days from the date of the alleged unlawful conduct."

# **SUMMARY**

Section IV B. of the CCWA Investment Policy states the "...Authority **Finance Committee** shall serve as the Investment Oversight Committee. The purpose of the Committee is to: (1) review the investment practices used by the Investment Officer for compliance with the investment policy and written procedures, (2) analysis of the quarterly Treasurer's report for adherence to established guidelines, and (3) advise Authority Board of Directors of any deviations from guidelines or any practices which are deemed to be imprudent for a public agency."

The proposed revision will amend the paragraph above to state the following:

The Board of Directors will (1) review the investment practices used by the Investment Officer for compliance with the investment policy and written procedures, (2) analyze the quarterly Treasurer's report for adherence to established guidelines, and (3) advise of any deviations from guidelines or any practices which are deemed to be imprudent for a public agency."

The CCWA investment policy will continue to be reviewed annually for any significant changes in Government Code Sections to ensure the preservation of principal, liquidity and return and the policy relevance to current law and financial trends. The quarterly investment reports will continue to be submitted to the Board of Directors along with a statement of compliance of the portfolio with the investment policy guidelines and a statement of the Authority's ability to meet the cash expenditure requirements for the next six months.

The only change to the investment policy is the delegation of investment oversight duties to the Board of Directors and the elimination of the CCWA Finance Committee per CCWA Resolution 23-04.

### RECOMMENDATION

That the Board of Directors approve the proposed amendment to the CCWA Investment Policy.

# STATEMENT OF INVESTMENT POLICY

# I. PURPOSE:

This statement is intended to provide guidelines for the prudent investment of the Authority's cash balances, and outline the policies for maximizing the efficiency of the Authority's cash management system. The ultimate goal is to enhance the economic status of the Authority while protecting its assets.

# II. SCOPE

It is intended that this policy cover all funds and investment activities under the direct authority of the Authority Board of Directors.

# III. OBJECTIVES

- A. Safety. Safety of principal is the foremost objective of the Authority. Each investment transaction shall seek to first ensure that capital losses are avoided, whether they be from securities defaults or erosion of market value.
- B. Liquidity. An adequate percentage of the portfolio should be maintained in liquid short-term securities which can be converted to cash if necessary to meet cash requirements.
- C. Yield. Yield shall become a consideration only after the basic requirements of safety and liquidity have been met.

- D. Market-Average Rate of Return. The investment portfolio shall be designed to attain a market-average rate of return throughout budgetary and economic cycles, taking into account the Authority's risk constraints, the cash flow characteristics of the portfolio, and State and local laws, ordinances or resolutions that restrict investments.
- E. Diversification. The investment portfolio will be diversified to avoid incurring unreasonable and avoidable risks regarding specific security types or individual financial institutions.
- F. Prudence. The standard of prudence to be used by investment officials shall be the "Prudent Investor Standard" per Government Code section 53600.3 which states: "care, skill, prudence and diligence under the circumstances then prevailing, including, but not limited to, the general economic conditions and the anticipated needs of the agency that a prudent person acting in a like capacity and familiarity with those matters would use in the conduct of funds of a like character and with like aims, to safeguard the principal and maintain the liquidity needs of the agency". This "Prudent Investor Standard" shall be applied in the context of managing an overall portfolio. Investment officers acting in accordance with written procedures and exercising due diligence shall be relieved of personal responsibility for an individual security's credit risk or market price changes, provided that deviations from expectation are reported in a timely fashion, and appropriate action is taken to control adverse developments.
- G. Public Trust. All participants in the investment process shall act as custodians of the public trust. Investment officials shall recognize that the investment portfolio is subject to public review and evaluation. The overall program shall be designed and managed with a degree of professionalism that is worthy of the public trust. In a diversified portfolio it must be recognized that occasional measured losses are inevitable, and must be considered within the context of the overall portfolio's investment return, provided that adequate diversification has been implemented.

# IV. DELEGATION OF AUTHORITY:

- A. Investment Officer. Management responsibility for the investment program is hereby delegated to the Treasurer, who shall establish written procedures for the operation of the investment program, consistent with this policy. Such procedures shall include explicit delegation of authority to persons responsible for investment transactions. No person may engage in an investment transaction except as provided under the terms of this policy and the procedures established by the Treasurer. The Treasurer shall be responsible for all transactions undertaken and shall establish a system of controls to regulate the activities of subordinate officials.
- B. Investment Oversight Committee. The Authority Finance Committee shall serve as the Investment Oversight Committee. The purpose of the Committee is to: (1) review the investment practices used by the Investment Officer for compliance with the investment policy and written procedures, (2) analysis of the quarterly Treasurer's report for adherence to established guidelines, and (3) advise Authority Board of Directors of any deviations from guidelines or any practices which are deemed to be imprudent for a public agency.

Investment Oversight. The Board of Directors will (1) review the investment practices used by the Investment Officer for compliance with the investment policy and written procedures, (2) analyze the quarterly Treasurer's report for adherence to established guidelines and (3) review for deviations from guidelines or any practices which are deemed to be imprudent for a public agency.

# V. INTERNAL CONTROLS:

The Investment Officer shall establish a system of internal controls which shall be documented in writing. The internal controls shall be reviewed with the independent auditor. The controls shall be designed to prevent losses of public funds arising from fraud, employee error, and

misrepresentation by third parties, unanticipated changes in financial markets, or imprudent action by employees and officers of the Authority.

## VI. REPORTING:

The Investment Officer shall submit quarterly to the Board an investment report that summarizes all securities. For those securities with a maturity of more than 12 months, the type of investment, institution, date of maturity, investment amount, market value, and yield will also be provided. The Investment Officer shall also provide, on a quarterly basis, a statement of compliance of the portfolio with the Statement of Investment Policy and a statement of the Authority's ability to meet the expenditure requirements for the next six months.

# VII. APPROVED INSTRUMENTS:

The Authority shall be governed by the California Government Code, Sections 53600 et seq. Where this policy specifies a percentage limitation for a particular category of investment, that percentage is applicable only at the date of purchase. Within the context of these limitations, the following investments are authorized, provided, however, that where there is no limitation on the term of the investment, no investment shall be made in any security which, at the time of the investment, has a term remaining to maturity in excess of 5 years, unless specifically exempted in Section X of this Investment Policy or the Board has granted express authority to make that investment no less than 3 months prior to the investment:

- (a) United States notes, bonds, bills, or certificates of indebtedness, or those for which the full faith and credit of the United States are pledged for the payment of principal and interest.
- (b) Obligations issued by government sponsored corporations such as the Federal Farm Credit Bank System (FFCB), the Federal Home Loan Bank Board (FHLB), and the Federal National Mortgage Association (FNMA).

(c) Commercial paper of prime quality of the highest ranking or of the highest letter and numerical rating as provided by Moody's Investors Service, Inc. or Standard and Poor's Corporation. Eligible paper is further limited to issuing corporations that are organized and operating within the United States and having total assets in excess of five hundred million dollars and have a rating of A-1+ by Standard & Poor's Corporation and P-1 by Moody's Investors Service and which matures not more than 270 days after the date of purchase. Purchases of commercial paper may not exceed 25 percent of the Authority's surplus money invested.

Commercial paper investments with one company may not exceed one-third (33 1/3%) of total commercial paper investments.

- (d) Time deposits. The Authority may invest in non-negotiable Certificates of Deposit at commercial banks and savings and loan associations that are collateralized in accordance with the California Government Code.
- (e) Local Agency Investment Fund. The Authority may invest in the Local Agency Investment Fund (LAIF) established by the State Treasurer up to the maximum permitted by State law.
- (f) Money market funds rated "AAAm" or AAAm-G" or better by Standard & Poor's Corporation.
- (g) Collateralized money market accounts. The Authority may invest in money market accounts at commercial banks and savings and loan associations that are collateralized in accordance with the California Government Code.

# VIII. DEPOSITORIES:

The Treasurer will establish selection criteria in conformance with Government Code Sections 53630.5, 53635.8, and 53638 for pre-approval of institutions with which to do business. To qualify for selection an institution must be a California branch office of a foreign, state, or national bank that is authorized under the law of its domicile and federal law. Pre-approved institutions will carry sufficient insurance from the Federal Deposit Insurance Corporation or the National Credit Union Administration insurance, and maintain policies as indicated in Government Code Section 53635.8 regarding insurance and capitalization of deposits. A written list of approved institutions will be maintained by the Investment Officer.

# IX. BROKER/DEALERS:

To provide for the optimum yield in the investment of the Authority's funds, the Authority's investment procedures shall be designed to encourage competitive bidding on transactions from approved brokers/dealers. In order to be approved by the Authority, the dealer must be a primary dealer reporting to the New York Federal Reserve, unless a comprehensive credit and capitalization analysis reveals that the firm is adequately financed to conduct public business; the dealer must be experienced in institutional trading practices and familiar with the California Government Code as related to investments; and other criteria as may be established in the investment procedures.

# X. MATURITY RESTRICTIONS:

In addition to the 5 year limitation on investments specified in this policy, the average maturity of the Authority's combined portfolio shall not exceed 2 years without prior approval of the Board (for a specified period). Reserve Fund investments are exempt from this restriction; however, reserve fund investment maturities shall be limited to or prior to final maturity of the Authority's Bond Financing.

# XI. RISK TOLERANCE

The Authority recognizes that investment risks can result from issuer defaults, market price changes or various technical complications leading to temporary illiquidity. Portfolio diversification is employed as a way to control risk. The Investment Officer is expected to display prudence in the selection of securities as a way to minimize default risk. No individual investment transaction shall be undertaken which jeopardizes the total capital position of the overall portfolio. The Investment Officer shall periodically establish guidelines and strategies to control risks of default, market price changes, and illiquidity. In addition to these general policy considerations, the following specific policies will be strictly observed.

# XII. SAFEKEEPING AND CUSTODY:

To protect against potential fraud and embezzlement, the assets of the Authority shall be secured through third-party custody and safekeeping procedures. The Investment Officer shall be bonded to protect the public against possible embezzlement and malfeasance. Safekeeping procedures shall be reviewed annually by the independent auditor and any irregularities noted should be reported promptly to the Treasurer and the Board.

### XIII. PERFORMANCE EVALUATION AND OPERATIONS AUDIT:

The quarterly investment reports submitted to the Board shall contain sufficient information to permit an independent organization to evaluate the performance of the investment program.

# XIV. ETHICS:

All persons authorized to place or approve investments shall report annually on Form 700 of the Fair Political Practices Commission all required economic interests for that year.

# XV. UPDATE OF POLICY:

This investment policy shall be reviewed at least annually to ensure its consistency with the overall objectives of preservation of principal, liquidity, and return, and its relevance to current law and financial and economic trends.

**SUBJECT:** Adoption of Final FY 2023/24 Budget

## **SUMMARY**

The Preliminary FY 2023/24 Budget was provided to the CCWA Board of Directors at its regular meeting on March 23, 2023. This report will highlight the proposed changes to the FY 2023/24 Preliminary Budget and request that the Board approve the proposed final budget.

### DISCUSSION

The following changes are presented for the Board's consideration and inclusion in the final FY 2023/24 Budget. The proposed final FY 2023/24 Budget is \$ 56.4 million or unchanged from the Preliminary FY 2023/24 Budget and \$ 5.3 million more than the final FY 2022/23 Budget.

- ➤ Increase of \$85,000 in Non Capital Projects for additional costs associated with the new financial and document management systems and safety system software.
- ➤ Increase of \$ 76,266 in project costs for the Mesa Verde Road Patch and Slurry Seal.
- Increase of \$ 43,498 in project costs for the purchase of a new pneumatic tire lift.
- Decrease of \$ 260,564 in DWR Fixed costs due to an increase in the Rate Management Credits.
- ➤ Increase in Warren Act and Trust Fund charges of \$ 55,800 for a total rate per AF of \$ 166.38. The Trust fund payment of \$ 43 per acre foot remains unchanged and the USBR Warren Act rate per AF will increase from \$ 95.39 to \$ 123.38 per AF effective October 1, 2022 to September 30, 2023.

As the table above shows, the proposed final FY 2023/24 budget is about \$ 5.3 million more than the prior year budget. The increase is primarily attributed to \$ 2.9 million increase in Fixed and Variable DWR pass thru costs, \$ 1.2 million increase in CCWA O&M expenses offset by a decrease of \$ 0.4 million in Warren Act charges. There is also an increase of \$ 1.1 million for Capital/Non-Capital projects.

The attached FY 2023/24 Proposed Final Budget in Brief document will provide a full overview of the proposed final budget and changes when compared to the FY 2022/23 Budget. Additionally, the attached FY 2023/24 Total Expenditures Summary provides each project participant a summary of the total expenditures by component for their agency.

# **Ten-Year Financial Plan Projections**

The Ten-Year Financial Plan Projections for each project participant will be updated based on the Board approved Final FY 2023/24 Budget and posted on the CCWA web server in each participant's folder. These projections are estimates only, and are intended to provide a basis for anticipated future costs associated with the large DWR capital expenditures.

# Approval to Obtain Bids for Projects Included in the Budget

In conjunction with the requested approval of the FY 2023/24 Budget, staff is also requesting approval to obtain bids for those projects included in the budget which require a formal bidding process. As always, CCWA staff will present the results of the bids for each project to the Board for final acceptance and approval.

# **RECOMMENDATION**

That the Board approve the Final FY 2023/24 Budget as outlined in this report and that CCWA staff be authorized to obtain bids for those projects included in the FY 2023/24 Budget which require formal bids.







The significant fluctuations in DWR fixed costs year-toyear is due to the DWR Transportation Minimum OMP&R cost component and its calculation for annual over and under-collections.

Historically, the Transportation Minimum cost component of DWR Statement of Charges has been the most volatile DWR charge. The volatility is partly based on DWR's Statement of Charges being based on estimates and then reconciling or preparing a "true-up" based on the actual costs incurred.







**SUBJECT:** Authorizing Teleconferencing for Special Meetings of the Board of Directors and

**Subordinate Committees** 

### SUMMARY

Staff proposes adoption of a resolution to permit the Board and its subordinate committees (i.e., the Operations Committee) to hold **special meetings** of the Board and its subordinate committees remotely, as permitted by the Brown Act. Regular meetings of the Board and its subordinate bodies will continue to meet in person.

# RECOMMENDATION

Staff recommends that the Board of Directors:

1. Approve Resolution No. 23-05

# **DISCUSSION**

With the termination of the Governor's COVID-19 state of emergency that supported the Board's reliance on AB 361 to conduct remote meetings during the COVID-19 pandemic, the Board returned to in-person meetings and requested a report on options to continue teleconferencing. At the March 23, 2023 Board meeting, the Board discussed these options and concluded that it preferred to meet in person going forward, but that it would like the option to meet remotely for any special meetings of the Board or its constituent bodies (i.e., the Operating Committee).

Historically, special meetings of the Board have been convened to take action on urgent matters and matters that do not require significant discussion. Hence, permitting teleconferencing for special meetings would avoid time and travel costs for those board members who are located relatively far from CCWA's office in Buellton.

The Board further specified its desired format for teleconferenced special meetings, which will consist of all board members participating in-person from either CCWA's office in Buellton or from the office of counsel (Brownstein Hyatt Farber Schreck), located at 1021 Anacapa Street, 2nd floor, in the City of Santa Barbara ("Brownstein location"). Members of the public may participate remotely or in person at either the CCWA office location or the Brownstein location.

Section 10 of the amended Joint Exercise of Powers Agreement provides that,

The Board shall meet at the Authority's principal office or at such other place as may be designated by the Board. The time and place of regular meetings of the Board shall be determined by resolution adopted by the Board; a copy of such resolution shall be furnished to each Member and Associate Member...

The Board's designated meeting place is CCWA's principal office, in Buellton. Since the Board has elected to meet remotely for special meetings, it is recommended that the Board pass the proposed Resolution establishing the additional meeting location for special meetings only. It is also recommended that the Board authorize its subordinate bodies to hold special meetings remotely for the same reasons described above.

# **ENVIRONMENTAL REVIEW**

CEQA Guidelines Section 15061(b)(3) provides a "common sense" exemption to environmental review that CEQA only applies to projects that have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to review.

The Board's approval of Resolution No. 23-05 does not have a potential for causing an significant effect on the environment.

# **RESOLUTION NO. 23-05**

# RESOLUTION OF THE BOARD OF DIRECTORS OF THE CENTRAL COAST WATER AUTHORITY AUTHORIZING REMOTE TELECONFERENCE SPECIAL MEETINGS OF THE BOARD UNDER THE RALPH M. BROWN ACT

**WHEREAS**, section 10 of the Joint Exercise of Powers Agreement Creating the Central Coast Water Authority ("Authority") provides that the Board shall meet at the Authority's principal office in Buellton "or at such other place as may be designated by the Board;" and,

**WHEREAS**, said Agreement further provides that, "Regular, adjourned and special meetings shall be called and held in the manner as provided in ... the Brown Act;" and,

**WHEREAS**, the Ralph M. Brown Act allows teleconferencing to be used "for all purposes in connection with any meeting, provided certain conditions outlined in Government Code section 54953 are met;" and,

**WHEREAS**, during the California COVID-19 state of emergency, all meetings of the Board and subordinate bodies were conducted remotely under Brown Act teleconferencing procedures; and,

**WHEREAS**, on termination of said emergency, the Board and subordinate bodies returned to in-person meetings; and,

WHEREAS, having received a report from Authority counsel at the March 23, 2023 Board meeting on options for remote meetings, the Board herein authorizes the use of teleconferencing for special meetings of the Board and its subordinate bodies, finding that such meetings in particular are often called for the purpose of deciding and resolving issues that are short or urgent in nature and that do not require significant discussion. Remote teleconferencing thereby would avoid time and travel expenses for board and committee members who must attend a special meeting.

# NOW THEREFORE, THE BOARD OF DIRECTORS DOES HEREBY RESOLVE AS FOLLOWS:

**Section 1**. Recitals. The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.

**Section 2**. Remote Teleconference Special Meetings. The Board hereby authorizes remote teleconferencing for *special meetings* of the Board and its subordinate bodies, including but not limited to the Operating Committee, in compliance with Government Code section 54953. For such meetings, Board or committee members, as applicable, shall participate in-person at either the Authority's principal office in Buellton or at the office of counsel, Brownstein Hyatt Farber Schreck LLP, located at 1021 Anacapa Street, 2<sup>nd</sup> floor, in the City of Santa Barbara. Board or committee members, as applicable, at one location will participate via teleconference with Board or committee members at the other location.

**Section 3**. <u>Effective Date</u>. This Resolution shall take effect immediately upon its adoption.

**Summary:** Would set a policy for the state to purchase or specify, on a statewide basis, at least 10%, by volume, of cement and concrete, including supplementary cementitious materials, that meet a certain benchmark by 2030 and to exclude the purchase of fossil-based supplementary cementitious materials by 2035. The bill would require, by March 31, 2024, the Department of Transportation, in consultation with the Department of General Services, to develop a model advance procurement agreement for the purchase or specification of low-carbon cement and low-carbon concrete products up to 10 years in advance that would facilitate the development of production of concrete, cement, and supplementary cementitious materials that meet or exceed the benchmark for low-carbon cement and concrete and, would, in meeting the goals described above, authorize state agencies to use the model agreement for the purchase or specification of low-carbon cement and low-carbon concrete products.

**Summary:** Would require the State Water Resources Control Board to adopt a final update of the 1995 Water Quality Control Plan for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary, as provided, before the board may consider a change in point diversion or any other water rights permit or order for the Delta Conveyance Project. The bill would also, if, after completing the update of the plan and in compliance with existing law, the board approves a change in point of diversion or any other water rights permit or order associated with the Delta Conveyance Project, prohibit the operation of the Delta Conveyance Project unless and until the updated plan is fully implemented. The bill would specify that these provisions do not constitute an authorization for or approval of funding for the Delta Conveyance or any other isolated Delta conveyance project and do not reduce any statutory or other regulatory conditions or permit requirements for Delta Conveyance projects.

**Summary:** Current law, until January 1, 2029, authorizes local agencies, defined as any city, county, city and county, or special district authorized by law to provide for the production, storage, supply, treatment, or distribution of any water from any source, to use the progressive design-build process for up to 15 public works projects in excess of \$5,000,000 for each project, similar to the progressive design-build process authorized for use by the Director of General Services. Current law requires a local agency that uses the progressive design-build process to submit, no later than January 1, 2028, to the appropriate policy and fiscal committees of the Legislature a report on the use of the progressive design-build process containing specified information, including a description of the projects awarded using the progressive design-build process. Current law requires the design-build entity and its general partners or joint venture members to verify specified information under penalty of perjury. This bill would authorize all cities, counties, city and counties, or special districts to use the progressive design-build process for other projects in addition to water-related projects and would extend these provisions until January 1, 2030. The bill would change the required reporting date to no later than December 31, 2028.

**Summary:** The California Environmental Quality Act (CEQA) requires a lead agency, as defined, to prepare, or cause to be prepared, and certify the completion of an environmental impact report (EIR) on a project that the lead agency proposes to carry out or approve that may have a significant effect on the environment or to adopt a negative declaration if it finds that the project will not have that effect. CEQA also requires a lead agency to prepare a mitigated negative declaration for a project that may have a significant effect on the environment if revisions in the project would avoid or mitigate that effect and there is no substantial evidence that the project, as revised, would have a significant effect on the environment. CEQA establishes a procedure by which a person may seek judicial review of the decision of the lead agency made pursuant to CEQA. This bill would require the Judicial Council to

adopt rules of court applicable to actions or proceedings brought to attack, review, set aside, void, or annul the certification or adoption of an environmental impact report for specified water conveyance or storage projects, as defined, or the granting of any project approvals, including any appeals to the court of appeal or the Supreme Court, to be resolved, to the extent feasible, within 270 days of the filing of the certified record of proceedings with the court to an action or proceeding seeking judicial review of the lead agency's action related to those projects.
